The Finance Director has the right to demand further proof of identity and other facts to establish any claim and may accept or reject a claim. If the claim is rejected, the claimant may file a verified complaint seeking to recover all, or a designated part, of the Unclaimed Property in a court of competent jurisdiction within Riverside County and serve a copy of the complaint and summons upon the Finance Director. A copy of the complaint and summons must be served within thirty (30) days of receiving the District's notice the claim was rejected.
