

2017 CVWD Flood to Drip Conversion Rebate Program Guidelines

CVWD is accepting applications from Coachella Valley growers within the CVWD boundary for converting flood irrigation systems to drip irrigations systems. Rebates of up to \$240,000 (\$1,500 per acre up to 160 acres) per applicant are available.

Qualified applicants will be awarded funding on a first-come, first-serve basis. A total of \$1 million in flood to drip rebate grants will be awarded to qualifying applicants. Rebates of \$1,500 per acre up to a maximum of 160 acres per project (\$240,000 cap per applicant) will be awarded to growers who qualify for rebates.

Based on the level of participation CVWD may increase or remove the cap per applicant.

Applicants will be required to achieve a MINIMUM POST-PROJECT WATER SAVINGS OF AT LEAST 3 ACRE FEET PER ACRE. Applicants must include the TOTAL PROJECT AREA in their application.

- Online submittal is available at www.cvwd.org/floodtodriprebate
- Applicants must submit plans for all areas to be converted from flood to drip irrigation. Plans must clearly show:
 - Total project area
 - Proposed permanent drip irrigation system description/layout
 - Method of abandonment of flood irrigation system
 - Description of irrigation materials to be installed
 - Estimate of total water savings
- Post conversion water use must be at least 3 acre foot per year per acre less than the past 5 years average historical use.
- Rebates will be paid by CVWD after the project has been completed in accordance with the guidelines and applicant's approved plans.
- Projects must be completed within one year of project approval.
- Applications, water use data, and CVWD project documentation will be shared with United States Bureau of Reclamation. Names will be omitted for customer privacy.
