ABOUT THE PROGRAM

Coachella Valley Water District (CVWD) is offering a rebate program to eligible commercial, institutional, multi-family residential, and hotel/motel customers within CVWD's service area. Customers who replace toilets using 1.6 gallons per flush (GPF) or greater with water efficient toilets of 1.28 GPF or less, or replace urinals that use 1.0 GPF or greater with waterless urinals, may qualify for a maximum \$140 rebate, or half the cost of the replacement, whichever is less. CVWD will reimburse the customer after all program conditions have been met. This program requires pre-approval.

TERMS AND CONDITIONS

ELIGIBILITY

All rebate Projects must be pre-approved before work begins. If you begin or complete your Project before applying and receiving pre-approval, your Project is not eligible for a rebate. **No retroactive rebates will be approved.** Eligible Projects will be funded on a first-come, first-serve basis. There is no guarantee that funds will be available for an entire Program year (July 1 through June 30).

ELIGIBILITY CRITERIA

1. Applicant must be a CVWD commercial, institutional, multi-family residential, or hotel/motel account holder.
2. Applicant must be the owner of the property site, or be a designated representative with photo ID and written authorization to represent the account holder or property owner.
3. Applicant's account must be in good standing.
4. Applicant's existing toilet must have a manufacturer's reported flow rate of 1.6 gallons per flush (GPF) or more. Existing urinals must currently use 1 GPF or greater.

CONDITIONS

1. Applicant must complete and sign a rebate application.
2. Applicant agrees to schedule, and allow, CVWD representative(s) onto the property for a pre-site inspection.
3. Written pre-approval must be received before purchasing and installing your water efficient toilet or urinal. Notification will be sent to the email address provided on the application or by USPS if no email was provided. **No retroactive rebates will be approved.**
4. Applicant agrees to purchase and install a water efficient toilet and/or waterless urinal at customer's expense.
5. Applicant can elect to install a leak detection system as part of the new toilet installation. A leak detection system is capable of detecting trace, measurable amounts of water and will provide an audible and/or visual leak indicator.
6. This program is not for new construction. Previously purchased and/or installed toilets or urinals do not qualify for a rebate.
7. Receiving pre-approval does not guarantee a rebate.
8. Applicant must complete their conversion and installation project within 60 days after written approval is given.
9. The installed toilets must qualify as a water efficient model with a rating of 1.28 GPF or less. The installed product must meet a waste extraction score (Maximum Performance—MaP) of 350 grams or better. Replacement urinals must be waterless.

CONDITIONS (continued)

10. Applicant must provide: (1) a cash register receipt along with the sales invoice, if one is issued, indicating the make and model purchased from a home improvement store, or other retail outlet or product vendor. For equipment purchased through a plumber or contractor, the invoice from the contractor with the make, model and cost of each toilet/urinal stamped "Paid in Full" will be acceptable as proof of payment. (2) Photos of disposed toilets/urinals as proof of completed work. Installations may be subject to site visit.
11. Applicant agrees that when all program requirements have been met, CVWD shall reimburse an amount up to \$140, or half the cost of replacement, whichever is less for each installed water efficient toilet and waterless urinal. Applicant may be asked to provide a Form W-9 in order to process rebate payment. A rebate check will be mailed to the applicant within 60 days.

RELEASE OF CLAIMS AND INDEMNIFICATION

By applying for or participating in any component of CVWD's Programs, personal information listed on your application may be subject to disclosure to any member of the public who requests it pursuant to the California Public Records Act.

Neither CVWD, its contractors or agents, makes any representation or warranty regarding the contracted services or products that you may select for your Project(s) under the Program. Installation of water efficient devices does not guarantee reduced water use. Any and all claims or causes of action you may have in connection with any defect or failure of performance of any contracted service or installed product or device provided to you for your project may only be pursued with the contractor you hired or the appropriate manufacturer/distributor.

By participating in the Program and accepting the rebates provided, you thereby release CVWD, its contractors and agents, from any and all claims and causes of action that may arise out of your purchase, installation, and/or use of water efficient devices in connection with the Commercial Water Efficient Toilet Rebate Program.

CVWD is responsible for operating and enforcing the Terms and Conditions of the Commercial Water Efficient Toilet Rebate Program. As the Program participant, you are responsible for ensuring that your Project complies with all applicable Federal, State and local laws, CVWD rules and regulations.

Further, you agree to indemnify, defend, and hold harmless the CVWD, its directors, officers, employees, contractors, and agents, from all liability and claims of any kind arising out of, or related to, purchase and installation, and use of water efficient devices in connection with this Program.
